Regardless of trauma origination, authors are asked to include a section on implications for professional practice that specifies areas of research need, practice focus, and policy implications.

Educational products including specialized curriculum, skill-building tools, and knowledge and awareness scales exist, but efforts to develop social work professionals with gerontological knowledge have had limited effects in many nations. Still, the population of older adults is growing internationally. Arguably ageism in social work education and training remains widespread.

This special section request manuscripts from authors to explore the current state or education and training in social work with older adults. Example submissions might include studies on workforce incentives, research on sustained knowledge and skill development about aging and older adults, biases within the social work profession, models of practice that are inclusive or exclusive of older adults as cocreators of care, innovations in social work curriculum, and commentaries that help readers understand the current state of social work education and training related to working with older adults.

Manuscripts may be submitted as commentaries, brief reports, research manuscripts, conceptual or theoretical analysis, policy analysis or knowledge translation study/activity. All submissions must include discussion of implications for social work practice at the individual, community and/or policy level.
